The undersigned, for the purpose of forming a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation Act, does hereby adopt the following Articles of Incorporation.

Article I - Name

The name of the Corporation shall be Catherine M. Catlin, P.A. The principal place of business of this Corporation shall be 3021 W. Azeele, Tampa, Florida 33609 or such other place as may be designated by the Board of Directors.

Article II - Duration

This Corporation shall have perpetual existence. The date and time of the commencement of corporate existence shall be upon the filing of these Articles.

Article III - Purpose

The Corporation is organized as a Professional Service Corporation as permitted under the Florida Statutes and the Corporation will be engaged in the practice of Law within the State of Florida, and to take all actions necessary or proper in

connection with that practice.

Article IV - Professional Services

The professional services of the Corporation shall be rendered only through its Officers, employees, and agents who are duly licensed or otherwise legally authorized to practice law within the State of Florida. Professional services shall be rendered in each case by the Officer, employee, or agent designated solely by this Corporation, acting through its duly elected Officers. This provision shall not be applicable to the extent it is in conflict with the law or the Rules Regulating The Florida Bar.

Article V - Capital Stock

The total authorized capital stock of this Corporation shall consist of Six Hundred shares of common stock having a par value of One Dollar (\$1.00) each, amounting in the aggregate to Seven Thousand Five Hundred Dollars (\$600.00). All stock issued shall be fully paid and non-assessable.

Article VI - Initial Registered Office and Agent

The street address of the initial registered office of this Corporation is 3021 W. Azeele, Tampa, Florida 33609, and the name of the initial Registered Agent of this Corporation at that address is Catherine M. Catlin.

Article VII - Initial Board of Directors

Every amendment shall be approved by the Board of Directors, proposed by them to the Shareholders, and approved at a Shareholders' meeting by a majority of the stock entitled to vote thereon, unless all the Directors and all the Shareholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.
