### ARTICLES OF INCORPORATION OF CRT - PR, INC.

### ARTICLE 1. - NAME

The name of this corporation is CRT - PR, INC.

# ARTICLE 2. - DURATION

This corporation shall exist perpetually unless dissolved according to Florida law.
