Dear Sir or Madam:

This firm represents **CHILDREN SERVICES OF FLORIDA, INC.**, a Florida corporation ("Children Services"). This letter requests that Children Services be reinstated for the reasons set forth in this letter.

Children Services was administratively dissolved for failure to file its 1996 annual report and pay the filing fee. Neither this office nor Children Services recall having received Children Services's 1996 annual report form.

We believe the annual report form was not received by us due to the Department's error in copying Children Services's address from the Articles of Incorporation to the Department's records. Children Services's principal business or mailing address set forth in the articles is a post office box in Naples. The Department's records apparently inserted as Children Services's mailing address a *portion* of the initial registered office address (1725 County Road 951, Golden Gate, Florida), but not the *entire* registered office address (the Department's records omitted the "Suite 106, Pine Plaza").

There are a number of businesses located at 1725 County Road 951. Without the designation of "Suite 106," the post office would not have known where to deliver the annual report.

I have enclosed the following:

2. Copy of Articles of Incorporation;


