ARTICLE I. NAME

The name of this corporation is MID FLORIDA MOBILE CAR CARE, INC. The principal place of business is 31931 Bay Street, Tallahassee, Florida, 32378. The mailing address is the same.

ARTICLE II. DURATION

This corporation shall begin its existence August 7, 1995.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is:

SEVEN THOUSAND FIVE HUNDRED (7,500.00) Shares  
of Common Stock having a Nominal or Par Value  
One Dollar (\$1.00) per share.

ARTICLE V. PREEMPTIVE RIGHTS

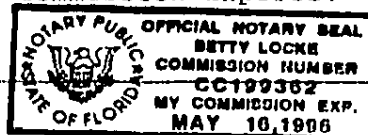
