#### ARTICLES OF INCORPORATION

OF

#### ARTICLE I. NAME

The name of this corporation is MID FLORIDA MOBILE CAR CARE, INC. The principal place of business is 31931 Bay Street, Tavares, Florida, 32778. The mailing address is the same.

## ARTICLE II. DURATION
