ARTICLE ONE

NAME

The name of the corporation is:

ARTICLE TWO

DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE

PURPOSE

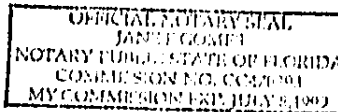

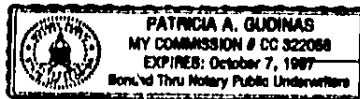
