

ARTICLES OF INCORPORATION OF TREADWAY ENTERPRISES, INC.



The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: Treadway Enterprises, Inc., and the address is: 6328 Ravenwood Drive East, Sarasota, Florida 34243.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3, Purpose. The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.
- Article 4. Capital Stock. The aggregate number of shares which the Corporation is authorized to issue is 10,000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.
- Article 5, Initial Registered Office and Agent. The street address of the initial Registered Office of the Corporation is 308 65th Street East, Bradenton, Florida 34208, and the name of its initial Registered Agent at that address is Hollis H. Treadway.
