**ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation for profit under Florida law, adopt the following articles of incorporation:

ARTICLE ONE: NAME

The name of the corporation is S & E DISTRIBUTING, INC.

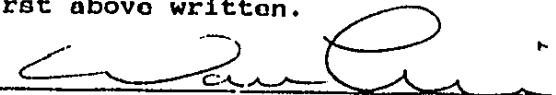

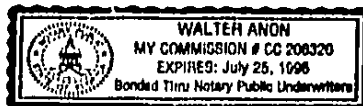
