The term for which this corporation shall exist shall be perpetual. The general nature of the business or businesses to be transacted by said corporation shall be as follows:

To own, lease, use experiment in buy, sell and develop patents and patent rights of all kinds and for items, objects, products, sechanisms and goods, and to enter into contracts for the purchase, sale disposition and traffic in same, both as principal and as agent.

To buy, sell trade, manufacture, assemble, and deal in and
