ARTICLES OF INCORPORATION

FIRST: The name of this corporation is: MEDIA FRANCHISES, INC. and its principal office is 524 Frances Street, Key West, Florida 33040, and the mailing address is c/o Bell & Company, CPA's, P.C., 535 Fifth Avenue, 21st Floor, New York, NY 10017.

SECOND: This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be formed under Chapter 607 of the Florida Statutes.

THIRD: This corporation is authorized to issue 200 shares of common stock without par value.

FOURTH: The name and address of the initial registered agent of this corporation is: Donna Lieb, 524 Frances Street, Key West, Florida 33040.

Subject to any provision in the certificate of incorporation, the business of the company shall be managed under the direction of a board of one director. Each director shall be at least eighteen years of age but need not be a shareholder. The number of directors may be increased or decreased by action of the shareholders entitled to vote or by the action of a majority of the total number of directors which the company would have if there were no vacancies. No decrease shall shorten the term of any incumbent director. The directors shall be elected at the annual meeting of the shareholders, and each director shall serve until the next succeeding annual meeting and until his successor has been elected and has qualified. Each of the first annual meeting of shareholders and until his successor has been elected and has qualified.
