Articles of Incorporation
of
Trisha R. Helms, Inc.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is **Trisha R. Helms, Inc.**

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purposes for which the corporation is organized are to act as contract carrier and broker for transportation and sale of produce and any other business authorized by Florida Statutes and permitted by law.

ARTICLE FOUR

The aggregate number of shares which the corporation is authorized to issue is one hundred (100) shares. Such shares shall be of a single class, and shall have a par value of Ten (\$10.00) Dollars per share.

ARTICLE FIVE

The street address of the initial principal office of the corporation is 627 South Sixth Avenue, Wauchula, Florida, and the mailing address of the corporation is Post Office Box 909, Wauchula, Florida 33873, and the name of its initial registered agent at such street address is **TRISHA R. HELMS**.

ARTICLE SIX

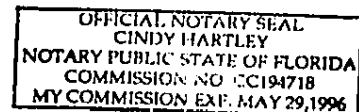
