ARTICLES OF INCORPORATION OF Bedorio's Grill Inc.

The undersigned, acting as incorporator of a corporation under Chapter 607 of the Florida Statutes, adopts the following Articles of Inco, poration for such corporation:

FIRST: The name of the corporation is Bedorio's Grill Inc.

SECOND: The principal address of the corporation is:
