ARTICLES OF INCORPORATION

OF

JIM & I GLASS, INC.

We, the undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the Laws of the State of Florida.

ARTICLE I

Name of Corporation

The name of the corporation shall be JIM & I GLASS, INC.

ARTICLE II

Nature of Business

The general nature of the business to be transacted by this corporation is wholesale sale of glass items or any other activities or business permitted under the laws of the United States and the State of Florida.
