ARTICLES OF INCORPORATION

<u>OF</u>

STA. ROSALIA, INC.

The undersigned subscriber(s), being natural person(s) competent to contract, hereby file the following Articles of Incorporation under the laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE 1

NAME: The name of the Corporation is STA. ROSALIA, INC.

ARTICLE II

DURATION: This corporation shall exist perpetually.

ARTICLE_III

<u>PURPOSE</u>: The purpose of this corporation is to have and exercise any and all powers necessary or convenient to effect its purpose and to otherwise engage in any lawful business permitted under the laws of the State of Florida.

ARTICLE IV

<u>CAPITAL STOCK</u>: This corporation is authorized to issue 50,000 shares of capital stock.

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.

ARTICLE V

INITIAL REGISTERED OFFICE AND AGENT: The street address of the initial registered office of the corporation is 322 Banyan Boulevard, West Palm Beach, Florida 33401 and the initial registered agent is RANDALL W. HENLEY.
