The undersigned, to form a corporation, by and under the provisions of the Statutes of the State of Florida, do subscribe to these Articles of Incorporation.

ARTICLE I - NAME

The name and mailing address of this corporation are SWIMMING POOL SERVICE COMPANY, 7605 Palmbrook Drive, Tampa, FL 33615.

ARTICLE II - DURATION

This Corporation shall have perpetual existence. The Corporate existence commences on the date of execution of The Articles of Incorporation.

ARTICLE III - PURPOSE

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK
