ARTICLES OF INCORPORATION

We, the undersigned, all being sui juris, do hereby agree for ourselves, under the laws of the State of Florida, Florida Statute 607 of seq, and the provisions therein providing for the formation, rights, liabilities, privileges, benefits, and obligations conferred and imposed by said laws on corporations for profit, do hereby subscribe to and adopt the Articles set forth herein.

ARTICLE ONE: Name

The name of this Corporation shall be Precision Boat Lift, Inc.

ARTICLE TWO: Effective Date and Duration

Precision Boat Lift, Inc. shall have an effective date of September 01, 1995 with perpetual existence.

ARTICLE THREE: Purpose

The general and specific purposes for which Precision Boat Lift, Inc. is organized are to:

- A. Engage in the business of manufacture and sale of mechanical boat lifts.
