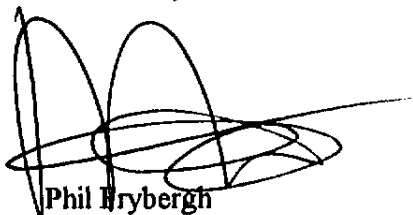
Dear Ms Mortham
