ARTICLE I.
CORPORATE NAME

The name of this corporation shall be

ARTICLE II.
NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to provide printing, publishing and advertising products and services to individuals and commercial organizations, to buy and sell real estate, to manage the properties for the corporation, and to engage in any and all business permitted under the laws of the United States and the State of Florida.
