ARTICLES OF INCORPORATION  
OF  
NATIONAL GOLF SERVICES, INC.

6/10/75

ARTICLE I: NAME

The name of this corporation is NATIONAL GOLF SERVICES, INC.

ARTICLE II: DURATION

This corporation shall exist perpetually, commencing on the date of execution and acknowledgment of these Articles of Incorporation.

ARTICLE III: PURPOSE

This corporation is organized for the purpose of engaging in any and all activities or business permitted under the laws of the State of Florida and the United States of America.

ARTICLE IV: CAPITAL STOCK

Initial Issue. One Hundred (100) shares of stock of the corporation shall be issued for cash or notes at a value of \$1.00 per share.

ARTICLE V: PRINCIPAL OFFICE AND REGISTERED AGENT

The address of the principal office of this corporation is 105 E. Robinson Street, Suite 301, Orlando, FL 32801 and the name of the registered agent of this corporation is Frank G. Finkbeiner.

ARTICLE VI: INITIAL BOARD OF DIRECTORS



ARTICLE IX: PREEMPTIVE RIGHTS



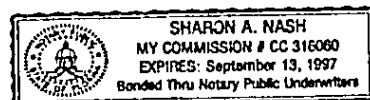
