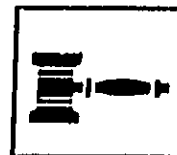

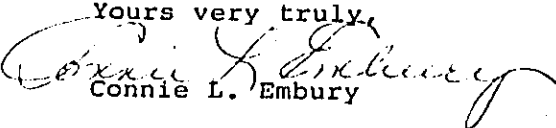

ARTICLES OF INCORPORATION  
OF  
ALL-TIMES PROFESSIONAL PICK UP AND DELIVERY SERVICE INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE: NAME: The name of the corporation shall be  
**ALL-TIMES PROFESSIONAL PICK UP AND DELIVERY SERVICE INC.**

ARTICLE TWO: DURATION: The term of existence of the corporation is  
perpetual.

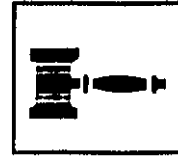
