ARTICLES OF INCORPORATION

OF

MEDICAL SUPPLIES & EQUIPMENT OF DADE, INC.

The undersigned subscribers to these Articles of Incorporation, desiring to form a corporation under the laws of the State of Florida, does hereby accept all of the rights and privileges, benefits and obligations conferred and imposed by said laws and does hereby adopt the following Articles of Incorporation as the Charter of the Corporation hereby organized.

ARTICLE I

NAME

The name of the corporation shall be;

MEDICAL SUPPLIES & EQUIPMENT OF DADE, INC.

ARTICLE II

DURATION

This Corporation shall have perpetual existence

ARTICLE III

PURPOSES AND POWERS

This Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida. The Corporation shall have all the powers set forth on the Florida General Corporation Law, as in effect from time to time, and including but not limited to the following power:

a) To transact the business sale, trade, rental of any and all types of durable medical equipments.

b) To construct, erect, repair and remodel buildings and attructures of all types for itself and others and to manufacture, purchase or otherwise acquire; and to own, mortgage, pledge, sell, or deal in and with, goods, wares, merchandise, personal property and services of every class, kind and description.

e) to act as broker, agent or factor for any person, firm or

corporation.

d) To purchase, lease or otherwise acquire real and personal property and leaseholds thereof and interests therein, and to own, hold, manage, develop, improve, equip, maintain and operate, and to sell, convey, exchange, lease or otherwise encumber any and all such property and any and all legal and equitable rights

thereunder and interests therein.

e) To borrow or raise money for any of the purposes of the corporation and from time to time without limit as to the amount to draw, make, accept, endorse, execute and issue promissory notes, drafts, bills of exchange, warrants, bonds debentures and other negotiable and nonnegotiable instruments and evidences of indebtedness, and to secure payment thereof and any interest therein by mortgage, pledge, creation of security interest, conveyance or other assignment in trust, whole or in part, of the assets of the corporation, real, personal or mixed, including contracts rights, whether at the time owned or thereafter acquired.

f) To quarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of or any bonds, security, or other evidences of indebtedness created by any other corporation of the state of Florida or any other state or government, and while owner of such stock to exercise all the rights, powers and privileges of

ownership, including the right to vote such stock.

g) To enter into, make perform and carry out contracts and arrangements of every sort and kind which may be necessary or convenient of every sort and kind which may be necessary or convenient for the business of the corporation or syndicate or any private, public or municipal body existing under the government of the United States or any states, territory, colony or dependency thereof of foreign government so far as or to the extent that the same may be done or pursuant to law.

h) To enter into or become a partner in any agreement for sharing profits, union of interests, cooperation, joint venture or otherwise with any persons, firm or corporation now carrying on or to establish one or more offices, both within the state of Florida and in any part or parts of the world, at which meetings of directors mat be held and all or any parts of the Corporation's business may be conducted; and to exercise all or any of its corporate powers territories, districts, dependencies, colonies or possessions in the United States of America and in any foreign contries.

i) To do everything necessary, proper, advisable or convenient for the accomplishments of any of the purposes of the attainment of any of the objects or the furtherance of any of the powers ferein set forth, and to do every other act and thing incidental thereto r connected therewith, to the extent permitted by law.

ARTICLE IV

CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time shall be five hundred shares (500) at one dollar par value.

ARTICLE V

AMOUNT OF CAPITAL

Any Director or Directors, officer or officers, individually or jointly, may be party or parties to or may be interested in any contract or transaction of or with this Componention or in which this Corporation with any person or persons, firm, association or corporation shall be affected or invalidated by the fact that any Director or Directors or officer or officers of this corporation is a party or are parties to, act or transaction or in any way connected with such person or persons, firm, association or corporation. Each and every person who may become Director or Directors or officer or officers of this Corporation is a party or are parties to, or interested in such contract, act or transaction or in any way connected with such person or persons, firm, association or corporation. Each and every person who may become director or officer of this corporation is hereby relieved, as for as is legally permissible, from any disability which might otherwise prevent him from contracting with the corporation for the benefit of himself or of any firm association or corporation in which he may be in anyway interested.
