ARTICLES OF INCORPORATION

OF

I, the undersigned, being desirous of forming a corporation under the Laws of the State of Florida, declare:

ARTICLE I

NAME

The name of this Corporation shall be:

ARTICLE II

AUTHORIZED SHARES

ARTICLES VIII

INDEMNIFICATION

a two-thirds vote, such settlement and reimbursement as being for the best interests of the corporation. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such director or officer may be entitled.
