THE UNDERSIGNED INCORPORATOR, being of the age of eighteen years or over, for the purpose of forming a corporation pursuant to Section 607.0401 of the Florida General Corporation Act, does hereby certify and adopt the following articles of incorporation:

FIRST: The name of the corporation is Weinstein Family Services, Inc. (the "Corporation").

SECOND: The address of the principal office and the mailing address of the Corporation is:

383 Street Road East  
Trevose, PA 19053

THIRD: The street address of the initial registered office of the corporation is c/o CT Corporation System, 1200 South Pine Island Road, Plantation, FL 33324, and the name of its initial registered agent at such address is CT Corporation System.

FOURTH: The period of duration of the Corporation is perpetual.

FIFTH: The purpose for which the Corporation is organized is to engage in the transaction of any or all lawful business for which corporations may be incorporated under the provisions of the Florida General Corporation Act.

SIXTH: The aggregate number of shares which the corporation shall have the authority to issue is 11,000 shares, divided into two classes. The designation of each class of shares, the authorized number of shares of each class, and the par value of the shares of each class, are as follows:

<u>Class</u>	<u>Number of Shares</u>	<u>Par Value Per Share</u>
Class A Common Stock	1,000	\$0.01
Class B Common Stock	10,000	\$0.01

SEVENTH: The relative rights, preferences and limitations of the shares of each class are as follows:

- (a) Each share of Class A Common Stock and each share of Class B Common Stock shall entitle the holder thereof to one vote on all matters submitted to a vote of the Corporation's shareholders.
- (b) The holders of Class A Common Stock shall not be entitled to receive dividends and shall have no right or entitlement to receive any distribution out of any earnings or cash flow of the Corporation.
- (c) The holders of Class B Stock shall have no restrictions upon right or entitlement to dividends or earnings or to any of the cash flow of the Company or otherwise out of any assets legally available therefor. Dividends may be paid on shares of Class B Common Stock as and when declared by the Board of Directors of the Corporation, out of any assets of the Corporation legally available for the payment of such dividends.

EIGHTH: The number of directors constituting the initial Board of Directors of this Corporation shall be six (6), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:




