ARTICLES OF INCORPORATION

We, the undersigned, hereby associate ourselves together for the purpose of forming a corporation for profit under the Statutes of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of such corporation.

ARTICLE I

The name of this corporation shall be:
Federal Insurance Investigators, Inc.

ARTICLE II

This corporation shall be authorized to engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

The maximum number of shares of stock which this corporation shall have outstanding at any time shall be Five Hundred (500) Shares of Common Stock with a par value of One (\$1.00) Dollar per share.

ARTICLE IV

The amount of capital with which this corporation shall begin business shall be at least Five Hundred (\$500.00) Dollars.

ARTICLE V

This corporation shall have perpetual existence.

ARTICLE VI

The principle office of this corporation is to be located at 37206 Clinton Avenue; Dade City, Florida 33525.

The Board of Directors shall have the power and the authority to establish branch offices and places of business of this corporation at any point in the State of Florida, or in any state, territory, or district of the United States, or in any foreign country, as they may deem necessary for the best interests of the business.

ARTICLE VII

The business of this corporation shall be conducted by the Board of not less than one (1) nor more than fifteen (15) directors. The Board of Directors shall have the power and authority to prescribe the consideration to be paid to the corporation in exchange for the issuance and disposal of its capital stock. The Board of Directors shall also have the authority and power to adopt by-laws which shall govern the operation of the business of this corporation, and thereafter amend the same from time to time, if necessary.

ARTICLE VIII

The subscriber to these Articles of Incorporation is over the age of Twenty-one (21) years, is sui juris, and is a citizen of the United States.

ARTICLE X

The corporation reserves the right to amend, alter, change or repeal any provision contained in the Articles of Incorporation, in the manner now or hereafter prescribed by statutes, and all rights conferred upon stockholders herein are granted subject to this reservation.

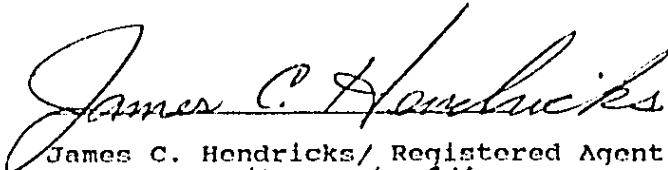
ARTICLE XII

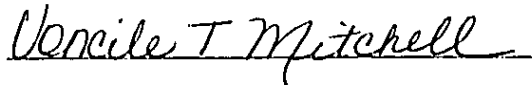
