First. The name of the corporation shall be SunRise Delivery Incorporated.

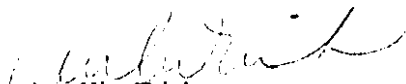

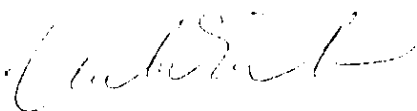
