I, the undersigned, hereby make, subscribe and acknowledge this Certificate for the purpose of becoming a Corporation under the Laws of the State of Florida.

ARTICLE I - NAME AND DURATION

The name and address of the person signing these Articles is Jose I Adan whose address is 12461 SW 5 Court, Ft Lauderdale, FL 33325.


ARTICLE VIII - INDEMNIFICATION


