ARTICLE I - NAME

The name of this corporation is Rons Cycle & Ski, Inc. (the "Corporation").

ARTICLE II - DURATION

The Corporation shall have perpetual existence.

ARTICLE III - PRINCIPAL OFFICE AND MAILING ADDRESS
