I, the undersigned natural person of the age of twenty-one years or more, do make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of Florida;

The name of the corporation is AMERISOURCE INTERNATIONAL, INC., whose principal office is located at 927 S.W. Woodcreek Drive, Palm City, Florida 34990.

H.

The period of duration of the corporation is perpetual unless dissolved according to Florida law.

III.
