ARTICLE I - NAME

The name of this corporation is BROWARD MILITARY ARMS SHOOTING CLUB, INC. The principal address of this corporation is 804 S. FEDERAL HIGHWAY, HALLANDALE, FLORIDA 33009.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.
