

ARTICLES OF INCORPORATION

OF:

WAYLON SOFTWARE CORPORATION

THE UNDERSIGNED do hereby associate WAYLON SOFTWARE

CORPORATION for the purpose of forming a corporation under the laws of the State of Florida, and do hereby certify as follows:

ARTICLE I - NAME

The name of the Corporation shall be: WAYLON SOFTWARE CORPORATION

ARTICLE II - PURPOSE

- A. To carry on and engage in the production and marketing of software products and to partake in all other acts necessary and related thereto.
- B. To carry on and engage in any business or activity which may be authorized and permitted under and by virtue of the laws of the United States of America or the State of Florida.

ARTICLE III - CAPITAL STOCK


