## ARTICLES OF INCORPORATION QE InterData Systems, INC.

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of incorporation for such corporation:

- 1. Name of Corporation. The name of this corporation shall be InterData Systems, INC.
- 2. <u>Duration</u>. The period of its duration is perpetual.
- 3. <u>Purposes</u>. The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.
- 4. <u>Capital Stock</u>. The corporation is authorized to issue 100 shares, all of one class common stock, at one dollar (\$1.00) par value each.

If all of the Directors severally or collectively consent in writing to any action taken or to be taken by the corporation, and the writings evidencing their consent are filed with the Secretary of the corporation, the action shall be as valid as though it had been authorized at a meeting of the Board of Directors.
- 10. <u>Indemnification</u>. The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.
- 11. By-Law Amendment. The power to adopt, alter, amend or repeal the By-Laws of this corporation shall be vested in the Board of Directors and Stockholders provided that such amendment shall be in compliance with the laws of the State of Florida.
