**Article I - Name**

The name of the corporation is Glojak, Inc.

**Article II - Duration**

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of the State of Florida.

**Article III - Purposes**

This corporation is organized for the purposes of transaction any or all lawful business.

**Article IV - Capital Stock**

This corporation is authorized to issue 1000 shares at \$1.00 par value, common stock, which shall be designated "Common Shares". 499 shall be held outstanding.

**Article V - Voting Rights**

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.

**Article VI - Preemptive Rights**

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

**Article VII - Initial Registered Office and Agent**

The street address of the initial registered office of this corporation is 3833 South Banana River Blvd. #403, Cocoa Beach, Florida 32931 and the name of the initial registered agent of this corporation at that address is : Gloria P. Lascha.

#### **Article VIII - Initial Board of Directors**

This corporation shall have one (1) director initially. The number of directors may be either increased or diminished from time to time by the bylaws, but shall never be less than one. The name and address of the initial director of this corporation is:

#### **Article XIV - Indemnification**

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

**Article XVI - Restrictions on Transfer of Stock**

Shares held by the initial stockholders listed above may not be resold or otherwise transferred to other persons unless such shares are first offered to the remaining shareholders or to this corporation.
