# Articles Of Incorporation Of Glojak, Inc.

Article I - Name

The name of the corporation is Glojak, Inc.

#### Article II - Duration

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of the State of Florida.

# Article III - Purposes

This corporation is organized for the purposes of transaction any or all lawful business.

## Article IV - Capital Stock
