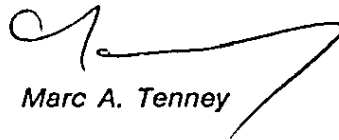

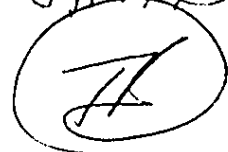

**OF**

The undersigned, for the purposes of forming a corporation under the Florida Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE ONE: NAME**

The name of the Corporation is: **\$1,000,000 CHALLENGE, INC.**

**ARTICLE TWO: DURATION**

The term of existence of the Corporation is perpetual.

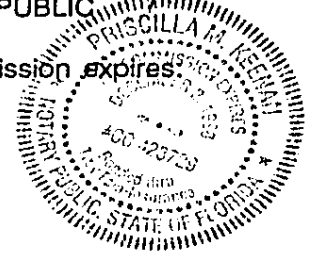

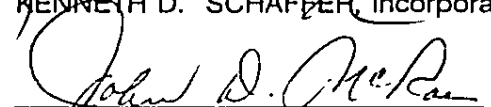
