ARTICLE FOUR

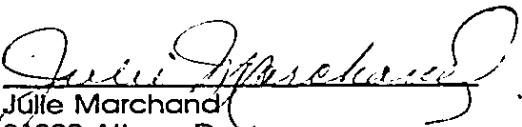
The aggregate number of shares whch the corporation shall have authority to issue is one thousand (1000) of no par value.
