ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME AND ADDRESS OF CORPORATION

The name of the corporation is SOUTHEAST ALUMINUM ENTERPRISES, INC., and its initial office is located at 7301 Nova Circle, Tampa, FL 33634.

ARTICLE II - DURATION

The duration of the Corporation shall be perpetual.

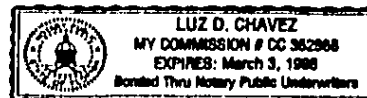
