The undersigned incorporators to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of Florida.

ARTICLE I. NAME:

The name of the corporation shall be **APPLIED COMPUTING SOLUTIONS, INC.**

ARTICLE II. NATURE OF BUSINESS:

The corporation may engage in any activity or business permitted under the laws of the United States and the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK:

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 50,000 shares of common stock having \$1.00 par value.

ARTICLE IV. TERM OF EXISTENCE:

The corporation shall exist perpetually and shall commence on the date of execution and acknowledgment of these Articles of Incorporation.
