ARTICLES OF INCORPORATION

We, the undersigned subscribers hereby organize an entity for the purposes of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation of a corporation for profit.

ARTICLE I

The name of this corporation shall be: TAYLOR COUNTY EQUITATION PARK. INC.

ARTICLE II

The general nature of the business and the objects and purposes proposed to be transacted and carried on are to do any and all of the things herein mentions, as fully and to the same extent as natural persons might or could do, to-wit:

1. To take, acquire, buy, hold, own, maintain, work, develop, sell, convey, lease, mortgage, exchange, improve and otherwise deal in and dispose of real estate and real property and all other kinds of property of whatever nature, whether real, personal or mixed or any interest or rights herein without limits as to amounts to buy, sell, assign, convey and cancel liens upon personal property and real estate and deliver bills of exchange, promissory notes, bonds, debentures and other negotiable instruments of whatsoever nature and serve the same by mortgage on its property or otherwise; to issue on commission, subscribe for, take, acquire, hold, exchange and deal in shares, stocks, lands, obligations or securities of any government or authority, individuals or corporations.

- 2. To carry on the business of a holding company and to purchase and acquire any mercantile, commercial or real estate business, trade or enterprise permitted by the laws of the State of Florida and to own, hold, operate maintain, use, sell or otherwise dispose of the same, to enter into or engage in any such business, trade or enterprise.
- 3. To form, promote and assist financially or otherwise syndicates and associations of all kinds and to give any lawful guarantee in connection therewith or otherwise for the payment of money or for the performance of any obligations or undertakings.
- 4. To acquire in any manner, enjoy, utilize, hold, sell, assign, lease, mortgage or otherwise dispose of, letter patent of the United States or of any foreign county, patents, patent rights, licenses and privileges, investments, improvements and processes, copyrights, trade marks and trade names or pending applications therefore relating to or useful in connection with any business of the corporation or any other corporation in which the corporation may have an interest as a stockholder or otherwise.
- 5. Generally to make and perform contracts of any kind and description and for the purpose of attaining any of the objectives of the corporation; to do and perform any other act or thing and to exercise any and all powers which a co-partnership or natural person could do and which now or thereafter may be authorized by law; generally to do and perform any and all things necessary or incident to the performing and carrying

out of the powers hereinabove specifically delegated or implied.

- 6. The business of this corporation is from time to time to do any one or more of all of the acts and things set out above and it shall have the right to conduct its business in all its branches in or outside the State of Florida or in any other state, territory or dependency of the United States or in foreign countries, it being the intention that each of the objects, purposes and powers specified in all of the provisions of this statement of purposes shall be regarded as independent objects, purposes and powers and to be in no manner nor to any extent limited or restricted by reference or inference by or from the terms of any clause of this statement or any other paragraph of these Articles of Incorporation.
- 7. To operate and engage in the purchase of real estate and the construction and maintenance of buildings and additions thereto on said real estate and to operate said real estate for the use of horsemanship activities.

ARTICLE III

The commencement date for this corporation shall be on filing these Articles of Incorporation with the Secretary of state of Florida.

ARTICLE IV

CAPITAL STOCK: The total number of shares of capital stock which may be issued by this corporation is four hundred (400) shares of common stock with a nominal or par value of \$100.00 per share. The initial stock offering shall be in accordance with Section 1244 of the Internal Revenue Code.

ARTICLE V

AMOUNT OF CAPITAL TO BEGIN BUSINESS WITH: The amount of capital with which this corporation shall commence business is not less than FORTY THOUSAND (\$40,000.00) DOLLARS.

ARTICLE VI
