Article I

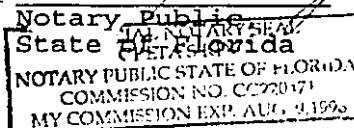




