ARTICLES OF INCORPORATION
OF

All shareholders are entitled to cumulate their votes for directors.

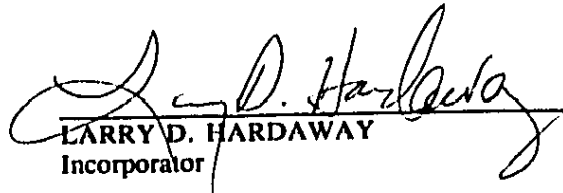
ARTICLE VIII.

These Articles of Incorporation may not be amended except with the concurrence of at least eighty percent (80%) of the outstanding shares.

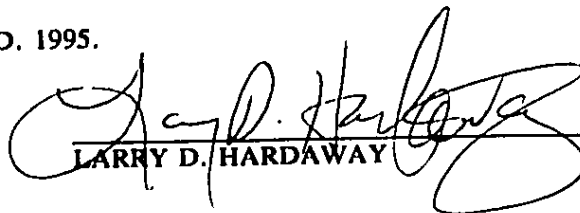
