The undersigned, acting as incorporator of Effective Computer Training, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

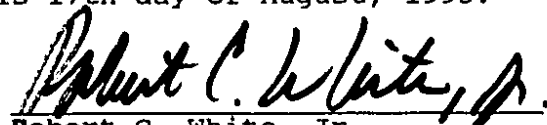

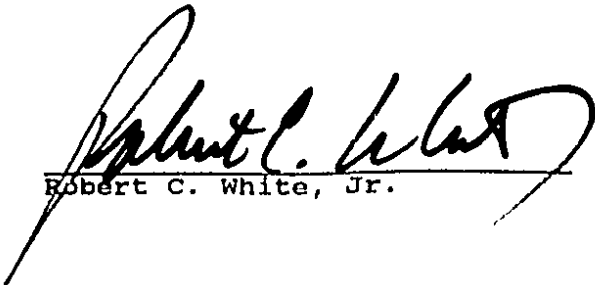

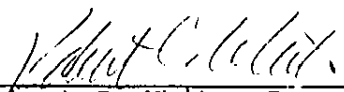
