I, the undersigned natural person of the age of twenty-one years or more, do make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of Florida;

I.

The name of the corporation is FAR MORE FUN, INC., whose principal office is located at 184 Klee Circle, Port St. Lucie, Florida 34953.

II.

The period of duration of the corporation is perpetual unless dissolved according to Florida law.

III.

The purpose for which the corporation is organized is for management of leisure activity centers to include skating rinks and retail units and any associated activities for which corporations may be organized under the laws of the United States and the General Statutes of the State of Florida.

The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purposes which may become necessary, profitable or desirable for the furtherance of the corporate objectives expressed above.

IV.

The corporation shall have the authority to issue 1,000,000 (one million) shares of common stock with a par value of \$1.00 (one dollar).

V.

The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is \$100.00 (one hundred dollars) in cash or property of equivalent value.

VI.

The manner in which the directors are elected or appointed will be stated in the bylaws of the corporation.


VII.


