ARTICLES OF INCORPORATION

The undersigned do hereby make, subscribe, acknowledge and file this certificate for the purpose of becoming a corporation under the Florida Business Corporation Act.

ARTICLE

Name

The name of the corporation shall be National Resource Group, Inc. The principal place of business of this corporation shall be 338 East Lemon Street, Tarpon Springs, Florida.

ARTICLE II

Nature of Business

The general purpose and nature for which the corporation is organized is to engage in the design, sale and performance of corporate training products and educational programs, seminars, conventions and consulting services, as well as to engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III

Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$1.00 per share.

ARTICLE IV


