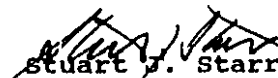

The undersigned, who is duly licensed to practice dentistry in the State of Florida, for the purpose of forming a professional corporation under Chapter 621 of the Florida Statutes, the Florida Professional Service Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I**
