ARTICLES OF INCORPORATION C & K TRUCKING, INC.

Corporation Act, hereby adopt the following Articles of Incorporation.

The undersigned, for the purposes of forming a corporation under the Florida gef

ARTICLE ONE NAME

The name of the corporation is C & K Trucking, Inc.

ARTICLE TWO DURATION

This corporation shall commence existence as of the date of execution of these articles. The term of existence shall be perpetual.

ARTICLE THREE **PURPOSE**
