The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby subscribe to, acknowledge and file the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of this corporation shall be:

**GREATER TAMPA BAY PRIMARY CARE NETWORK, INC.**

**ARTICLE II. PURPOSE**
