The undersigned, a natural person competent to contract,
hereby makes, subscribes, acknowledges and adopts the following
Articles of Corporation for the purposes of forming a corporation
under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be MIAMI AIR CARGO NEWS, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing

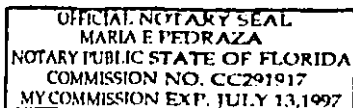

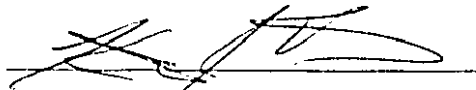
