ARTICLES OF INCORPORATION

OF

OROL MARINE, INC.

ARTICLE I

The name of this corporation shall be OROL MARINE, INC., and its' principal place of business shall be in Orange County, Florida, but it may establish branch offices at any other places deemed advisable by its Board of Directors within the State of Florida. The post office and street address of the corporation shall be 3568 Old Winter Garden Road, Orlando, Florida 32805.

ARTICLE II

The general nature of the business to be transacted and to be carried on by said corporation shall be:

To engage in the business of purchasing, acquiring, owning, leasing, selling, transferring, encumbering, generally dealing in, repairing, renovating, and servicing all types of new and used boats, canoes and other marine vehicles and any parts or accessories used in connection therewith; and generally dealing in all types of supplies used by all types of marine vehicles.

To engage in the retail and wholesale sales of boat parts and accessories.

To engage in and to own, operate and run, conduct and manage a business engaged in repairing and reconditioning boats, marine and mechanical products, and other personal property of any and every sort, character, nature, and description, and to do such other things as are incidental, proper, or necessary to the operation of the business, or to the carrying out of any or all of the purposes.

To render services in connection with storage of boats and to store the same, and to perform all services necessary and incidental to such storage, including the selling and supplying

This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

There shall be issued ONE THOUSAND (1,000) shares of Common Stock having a par value of TEN DOLLARS (\$10.00) per share, which shall be non-assessable, and payable in lawful money of the United States of America, or in property, labor or services at a just valuation to be fixed by the Directors of the corporation at the organization meeting held after the granting of the Charter herein applied for.

The Capital Stock of the corporation shall be sold, signed, issued and transferred only in accordance with the By-Laws as the corporation may from time to time change, alter or amend and the said corporation shall begin business with not less than FIVE HUNDRED DOLLARS (\$500.00) of Capital Stock paid in.

ARTICLE IV

This corporation shall have perpetual existence.

ARTICLE V

The business of the corporation shall be conducted by a President and a Board of Directors of not less than one (1) and not more than seven (7) members; but the number of Directors may be increased or decreased from time to time by the By-Laws of the corporation or by resolution of the stockholders at any annual or special meeting.

Other officers may, in the same manner, be created, established and filled.

Any number of offices may be held and filled by one and the same person.

The Directors shall be elected by the stockholders at each annual meeting of the stockholders which shall be held on the first Tuesday of the month of December of each year, but the

All officers shall be elected annually by the Directors.

ARTICLE VI

The Directors shall meet at the call of the President to adopt By-Laws and until their successors shall have been elected, the business of the corporation shall be conducted by the following named person:

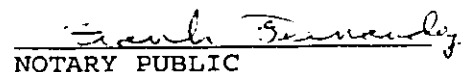

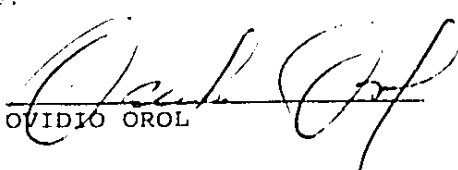

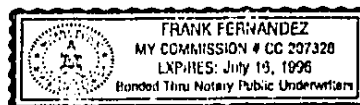
