**NAME**

The name of this corporation is **L & C MEDICAL BILLING SERVICE, CORP.**

**ARTICLE II**

**BUSINESS TO BE TRANSACTED**

The nature of the business to be transacted by the corporation is:

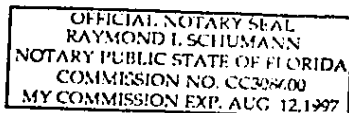
