STATE OF FLORIDA ARTICLES OF INCORPORATION OF CHAMPION MORTGAGE OF SOUTH FLORIDA, INC.

The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 621, Florida Statutes under the Florida Professional Service Corporation Act, adopt the following Articles of Incorporation:

ARTICLE 1

The name of the corporation is CHAMPION MORTGAGE OF SOUTH FLORIDA, INC. The principal office and mailing address is 2901 Clint Moore Road, Suite 9, Boca Raton, FL 33496.

ARTICLE II

This corporation is to exist perpetually.

ARTICLE_III

The purpose for which the corporation is organized is to engage in the transaction of any or all lawful business for which corporations may be incorporated under the provisions of the Florida General Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 300 Common Shares at \$1.00 par value.

ARTICLE V


